Affidavit of Janice Levinson, Co-Founder and Director of Protective Mothers Alliance International (PMA)

I, Janice Levinson, solemnly swear:

1. I am a professional colleague of William "Bill" Windsor. Bill Windsor and I have connected through our similar work in victim advocacy, though we have never met in person, we have spoken by phone and communicated through e-mail.
2. I have also have experienced similar cyber bullying, stalking and harassment from Claudine Dombrowski. My experience with Ms. Dombrowski has lasted on/off for the past four years and recently is becoming more escalated.
3. Ms. Dombrowski runs a victim advocacy organization, American Mothers Political Party (AMPP), that I have had professional dealings with in the past.
4. Ms. Dombrowski has engaged in defamation of character against myself and my organization causing damage to my reputation, my relationship with my family, my relationship with my friends and colleagues, and has damaged employment opportunities. Her attacks are unprovoked and when requested by me to peacefully resolve the issue, my efforts were refused.

5. Ms. Dombrowski's attacks involve numerous internet postings using numerous internet websites, professional websites, social networking and false names (to avoid detection). She has also made use of YouTube videos that she created to libel me, and encouraged friends to also create offensive videos. She has rallied friends to write my personal information including my phone number in bathroom stalls throughout the state of Florida. Ms. Dombrowski has also attempted to contact, or encouraged others to contact, professional colleagues to spread misinformation about me, and to scare people away from the organization that I direct.

6. Ms. Dombrowski has used offensive language, put up photos that she has stolen from my professional sites (without my permission), used my name without my permission in a manner that can only be viewed as threatening, especially now as her attacks escalate. Ms. Dombrowski has also attempted to discredit my organization, and attempted to intimidate me from attending a credible networking conference by using threatening language and posting this across the

internet so I was sure to see it.

Ms. Dombrowski's attacks are so severe that many clients (who wish to remain anonymous) report seeing them in public, and also feel threatened and frightened to the point that they refuse to network, and attend any online or in person events.

7. Examples of Ms. Dombrowski's attacks against me: creating a blog using my name (www.janicelevinson.blogspot.com) that includes calling me profane names (like bitch, hoe, and that I mercilessly slaughter you and your children), compares me to Adolph Hitler, falsely accuses me of being a "hoe" and having a romantic relationship with Bill Windsor (stating I am "in bedded with Lawless America" and posting photos of Bill and I next to suggestive pictures), making threats that "karma is a bitch and payback is a mother fucker" and posted a stolen picture of me with the words next to it "bitch I will fuck up your day with a smile on my face". She also stole a picture of myself and my daughter and surrounded it with vile, profane and derogatory statements about me and pictures of animals have sex with the caption "wild animal sex" written in the caption.
8. When you visit the janicelevinson.blogspot.com blog, and click on this picture of a wolf, it links directly to Ms. Dombrowski's organization, American Mothers Political Party, and includes comments that Bill Windsor is a sexual deviant and a sexual predator right on the front page of the AMPP site.

9. Ms. Dombrowski has copied these horrific articles from this page and reposted them on the internet, social networking sites and in professional business sites. In fact when you do a web search on my name, you will see her hateful sites come to the top of the search listings.

- 10. Ms. Dombrowski has also tried to discredit me to the co-founder of the organization that I work with, as to get me removed from my position.
- 11. Ms. Dombrowski has also tried to discredit me with potential clients to try to scare them away from my organization, and put us out of business. Alternately, she will start an online attack against anyone who supports me or my organization.
- 12. You will see my name, the name of the organization I work with, and even the co-founder's names tagged on her blogs in order to generate more popularity on the search engine so that these horrible lies come to the top of every search—it has been very difficult, if not impossible, to get this removed from Google, Facebook, Wordpress, Blogspot, Businessweek and other internet sites, including sites within the victim advocacy groups I work with.
- 13. In her most recent attacks, Ms. Dombrowski groups me and my organization with Bill Windsor, and Lawless America, and attacks us both in a similar fashion. When I asked Ms. Dombrowski to stop, she refuses and things only get worse.

- 14. After four years of abuse and threats, from Ms. Dombrowski (and her supporters), I fear for my safety. Even though Ms. Dombrowski does not live in my state, she has clearly shown that she is capable of inflicting physical harm and/or has friends/supporters willing to cause harm and/or inflict damage on her behalf.

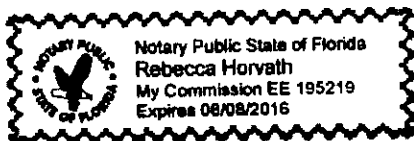
